15. The bid submitted without the EMD shall be summarily rejected. The property shall not be sold below the reserve price.
16. In case of any dispute arises as to the validity of the bid (s), amount of bid, EMD or as to the eligibility of the bidder, authority of the person representing the bidder, the interpretation and decision of the Authorised Officer shall be final.
