Whereas the Authorized Officer of Axis Bank Ltd. - 52 A Bidder need to give an Undertaking that he is interested to participate in the bid under present circumstances and will make the complete payment as per SARFAESI timelines.
- 53 The Bid(s) need to be submitted above the Reserve Price amount and any bid(s) received after the due date, time will not be considered as Valid.
- 54 The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.
- 55 As per Section 194 of Income Tax Act (as amended time to time), if property is sold above 50 Lakhs, then buyer will have to pay appropriate TDS to the Government treasury and the TDS certificate has to be deposited in the Bank.

- 59 In the event of any default in payment of any of the amounts, or if the sale is not completed by reason of any default on the part of the purchaser/bidder within the aforesaid time limit, the Bank shall be entitled to forfeit all the monies paid by the purchaser/bidder till then and put up the secured asset(s) / property (ies) for sale/disposal again, in its absolute discretion and may also resale/offer the same to the second highest bidder. - 61 Any disputes / differences arising out of sale of the immovable property (ies) / secured asset(s) offered for sale shall be subject to the exclusive jurisdiction of Courts / Tribunals at **Ahmedabad (Gujarat)** only.
