- 6 The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.

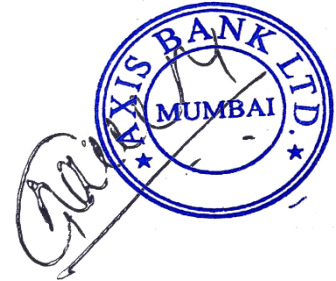
