Detailed Customer Journey on EazyDiner:

Discovery of Axis Bank Dining Delights Page

1. Customers can book their dining experience via the Axis Bank Program on EazyDiner. They can access the program directly through the Axis Bank Dining Delights link

<https://dining.eazydiner.com/axisbank> or via the EazyDiner App, where the Axis Bank Dining Delights Program is featured.

2. Once the customer lands on the Axis Bank Dining Delights page, the Booking and the Payment journeys mentioned below can be followed.

Booking Experience on Axis Bank Dining Delights Page:

1. Customers land on the Axis Bank Dining Delights landing page
2. Customers can view the dining offer from Axis Bank along with the cards on which the offer is applicable
3. The customers can select a restaurant of their choice. The restaurant tiles show restaurant details and available cuisine.
4. Once a restaurant is selected and customers click on “Book now”, the booking experience begins.
5. Customers select the date of dining, number of guests, dining deal (which is a combination of both restaurant discount and Axis Bank card offer) and enter the details viz. Name, phone number and email under guest details to book a table.
6. If a guest has already logged in, the guest details are automatically filled.
7. If a guest is a new customer, after clicking “Book”, an OTP validation is triggered to validate the phone number and complete the booking.
8. Booking confirmation is shown on the portal.

Payment Experience on Axis Bank Dining Delights on the EazyDiner app:

1. Customer clicks on “Pay Now”, enters the Bill amount and clicks Pay.
2. Axis Bank Dining Delights offers are shown to the customer to select the relevant offer based on the card that the customer has.
3. Offer is applied, and the discounted amount is shown to the customer. The customer then clicks "Pay".
